

#### INTRODUCTION TO THE SKILLS BASED TRAINING CURRICULA

The skill based training courses are the training content developed for enhancing the specific skills of existing professionals or provide for a platform for imparting skills to candidates with no formal qualification.

To undertake the skill based training programme, it is mandatory that the candidate must fulfil the entry criteria provided for the job profile. The training and assessment will certify that the candidate is able to undertake specific set of activities. This must not be equated with the formal qualifications- diploma/ degrees which are given by a University.

It is recommended that the employer must help the candidate in continuing the studies to degree level and formal qualification, if the candidate is willing for gaining knowledge and want to move up the traditional career pathway.

#### Who is a Child Care Aide?

A child care aide is a trained and certified health-care worker who attends to children at schools, businesses, private households, and child care institutions. She performs a variety of tasks like such as dressing, feeding, bathing, and overseeing play.

#### Scope of practice

Child Care Aides are responsible for helping and assisting new mothers and/or their families for the care of the child. They are responsible for all basic needs of baby care which may include reading to them and playing with them and any related work assigned by the mother/ family.

Childcare workers use play-way and other instructional techniques to help children's development. For example, they use storytelling and rhyming games to teach language and vocabulary. They may help improve children's social skills by having them work together to build something in a sandbox or teach math by having children count when building with blocks. They may involve the children in creative activities, such as art, dance, and music. Childcare workers also often watch school-age children before and after school.

As per the training module at the end of the training, the candidate would be certified to perform following activities—

- 1. Bathing, feeding, dressing children and changing diapers etc.
- 2. Maintain a safe play environment, observe and monitor children's play activities.
- 3. Sanitize toys and play equipment.
- 4. Communicate with children's parents or guardians about daily activities, behaviors, and related developmental issues.
- 5. Keep records on individual children, including daily observations and information about activities, meals served, and medications administered.

- 6. Support children's emotional and social development of the child.
- 7. Identifies signs of emotional or developmental problems in children and report to parents or guardians.
- 8. Instruct children in acquiring healthy personal habits including hygiene and toilet habits.

#### Minimum Entry requirement

Educational requirement - The candidate must have completed 10<sup>th</sup> with 2 years of work experience.

#### **Minimum Course duration**

It is recommended that any programme developed from this curriculum should have a minimum duration of 1000 hours (306 hours for theory, 334 hours of practical and 360 hours of internship) to qualify as an entry level professional in the field of Child Care Aide.

#### Teaching faculty and infrastructure:

- 1. Should be at the position of a Healthcare Instructor
- 2. B.Sc. (Nursing) with three years of teaching experience
- 3. Should be able to perform and train on related skills

#### Medium of instruction:

English/ regional language shall be the medium of instruction for all the subjects of study and for examination of the course.

#### Attendance:

A candidate has to secure minimum 80% attendance in overall with at least-

- 1. 75% attendance in theoretical
- 2. 90% in Skills training (practical) for qualifying to appear for the final examination.

No relaxation, whatsoever, will be permissible to this rule under any ground including indisposition etc.

#### TRAINING CURRICULA FOR SKILL CERTIFICATION

**Learning Outcomes**: At the completion of this module, the student should be able to perform the following:

- 1. Supervise infants and toddlers individually and in small groups.
- 2. Provide care, guidance and assist in healthy development of the children, meeting the early educational and emotional needs of the children.
- 3. Understand the physical and emotional requirements of the child like pain, hunger, fear etc.
- 4. Give each infant individual specialized attention each day, responding to each infant's/ child's specific needs.
- 5. Provide and assist in personal hygiene practices, including toileting issues as necessary.
- 6. Follow the developmental pattern of each child.
- 7. Report regarding the child's development and well-being, discuss the child's special needs or abilities.
- 8. Perform other duties as assigned.
- 9. Demonstrate the ability to perform basic skills essential in providing the care services.
- 10. Demonstrate professional behavior, personal qualities and characteristics of a Child Care Aide.

- d. Describe bullying and measures to prevent/ stop the habit in children
- e. Discuss gender equality and its importance in a civilized society

#### 3. Nurturing Children's Competence

- a. Discuss identification of special skills of children and methods to promote them
- b. Describe ways to promote competence in children with special needs
- c. Discuss utilisation of interest of children to promote development of other skills

#### 4. Good and bad touch

- a. Demonstrate teaching good and bad touch to children and talking about any advances by anybody
- b. Discuss identification of children with signs of depression over a past abuse
- c. Demonstrate talking to children to comfort them and get information out
- d. Discuss reporting of any case of child abuse to the family/ authorities

#### 5. Fun and Fitness: Addressing childhood procrastination

- a. Discuss the increasing prevalence of lack of physical exercise in children
- b. Discuss life-long benefits of physical fitness for children
- c. Demonstrate ways to promote physical activity in children
- d. Discuss the right eating habits and food products for children
- e. Discuss emotional wellness of children and linkages between emotional and physical wellness

#### **MODULE – 8: INTERNSHIP**

**Learning Outcomes**: At the completion of this module, the student should be able to:

- 1. Acquire all necessary skills of a Childcare Aide
- 2. Demonstrate the skills and attitude of an efficient care giver in supervised sessions

#### Details of Topics

- a. Training should be provided in home care and hospital set ups
- b. Trainees should be posted with play schools, creche, anganwadi centres, private nursing homes
- c. Trainees could be utilised in health awareness programs, immunization drives
- d. Trainees should be taken on visits of hospitals, Neonatal Intensive Care Units, maternity wards
- e. Clinical training should be undertaken in a structured manner with a training plan under supervision.
- f. A training plan that reflects tasks to be performed and competencies to be imparted should be prepared and signed teacher, and supervisor at the training facility, during the internship phase.
- g. The trainer should break down all the steps of child care and train the students as per the training plan:
  - The instructor or the trainer should explain every aspect of child care as per the syllabus.
  - The trainer should demonstrate each step in detail, followed by hands-on training in a supervised set up.
